#### **OVERVIEW**

Boyette Strategic Advisors completed an economic impact evaluation and analysis for job creation and capital investment in the 3-county South Western Kentucky Economic Development Council (SWK) region for 2022 – 2024. This project has assessed the potential economic impact resulting from new jobs and investment in existing or new facilities. The assessment includes the employment/payroll impact of new jobs being created, in addition to the impact of construction and equipment purchases by each company. The impact was conducted to measure the impact the companies' investment and job creation will have on Christian, Todd and Trigg counties.

#### **METHODOLOGY**

The Impact Evaluation and Analysis report examines, using both quantitative and qualitative measures, the true impact based on capital investment, employment, and wages for each of the 13 companies locating in the region between 2022 and 2024. The quantitative economic impact was modeled using the IMPLAN input-output model. Employment and investment data for this analysis represents all full-time, part-time, and seasonal employment, according to definitions used by the Bureau of Economic Analysis and Bureau of Labor Statistics.

The economic impact is measured in direct effects, which gauges the change in final demand of directly impacted industries; indirect effects, which captures business-to-business spending; and induced effects, which represents increased consumer spending.

A Social Accounting Matrix model was used to measure spending of households, governments, and inventory and export transactions. The model estimated inter-industry spending from purchaser to producer to determine the economy-wide impact. The impact values include payroll generated; contribution to the gross regional product (GSP) of the multi-county region; state and local tax impact; and total output, which includes the initial investment. Data used in the model is 2023, and all funds are expressed in 2025 values and adjusted for inflation/deflation.



#### **DATA PARAMETERS**

In response to an information request issued by Boyette, SWK provided data related to expected investment and subsequent employment. For purposes of this assessment, the variables provided by SWK were utilized to measure the impact of capital investment and job creation related to new facilities to be developed based on company announcements during the study time period. The capital investment spending is assumed to begin in 2024 for the facilities being constructed, with permanent employment to begin in 2025. Following is the data utilized for this project.

Results of this assessment are provided for the three-county SWK region, as well as for the individual counties in which one or more of these companies has located. For purposes of this report, 12 of the 13 companies located in Christian County and one located in Todd County. There were no locations between 2022 and 2024 in Trigg County.

### **SWK 3-County Region: QUANTITATIVE ECONOMIC IMPACT**

#### **SUMMARY**

The impact summary below reflects the overall impact of 13 company locations with their associated capital investment and job creation. The map at right illustrates the geography for this portion of the impact assessment. These projects have a total impact of nearly \$2.8 billion, with impact on the Gross Regional Product almost \$982 million. Labor income totals \$605 million with nearly \$71 million in state and local tax revenue. Multipliers provide an additional method of measuring impact that illustrates the indirect and induced impact of each individual component of the impact. For this impact analysis, every 10 jobs created by new and expanding companies results in an additional 8.5 indirect or induced jobs in the region.



### Job Creation & Capital Investment by Type






#### **State & Local Tax Detail**

The state and local tax impact of these 13 companies would be nearly \$71 million in the three-county SWK region, which includes corporate property taxes of almost \$14 million and business sales tax in excess of \$37 million. Personal income tax collected from direct, indirect, and induced employees would be more than \$11 million.

#### **REGIONAL INDUCED OUTPUT**

One component of the total impact is induced effects, which represents consumer spending that results from new direct and indirect jobs. This graph illustrates the top 15 industry sectors impacted by the aggregated induced effects of job creation and capital investment in the 3-county region. The sector with the **most significant induced impact is owner occupied housing**, with an impact of more than **\$23 million**; additionally, two other housing measures are included in the top 15. Limited service and full-service restaurants, along with retail general merchandise and retail motor vehicle and parts dealers are also in the top 15. A complete list of all impacted sectors can be found in the Appendices.



#### **EMPLOYMENT**

The impact of a new company locating in a region is driven in part by their employment and payroll. The 13 companies included in this impact analysis announced **2,494 new jobs**. The **total impact of employment is nearly \$2.0 billion** in the SWK region. This includes a total labor income of approximately \$333 million, which covers direct employment and additional positions that are associated with supply chain and consumer spending. State and local tax revenue resulting from this employment is **almost \$51 million**. Note that employment impact occurs annually as long as the number of employees remains steady.

State and local taxes generated as a result of the new companies locating in the SWK region would **total nearly \$51 million**. It should be noted that incentives are not accounted for in this data. Incentives would only have an impact on the direct taxes paid by the benefitting company. Indirect and induced tax impacts, which are not affected by incentives, total almost \$18 million.

#### **CAPITAL INVESTMENT**

Capital investment made by the companies announcing new or expanded locations between 2022 and 2024 has been aggregated to determine impact on the 3-county region. The total capital investment is nearly \$2.1 billion. Those expenditures result in a total impact of more than \$821 million, which includes an **increase in the region's GRP of nearly \$371 million** and supports more than **4,000 jobs**.


### **CHRISTIAN COUNTY: QUANTITATIVE ECONOMIC IMPACT**


#### **SUMMARY**

As mentioned earlier, 12 of the 13 announced location or expansion projects in the SWK region have occurred in Christian County. The total impact of those 12 projects totals nearly \$2.2 billion to Christian County. This includes an increase in the Gross Regional Product (GRP) of almost \$797 million, with nearly \$477 million in labor income in the region. These results include a state and local tax impact of nearly \$55 million. Additional details are found in the graphics and tables below.

#### Job Creation & Capital Investment by Type








#### **State & Local Tax Detail**

Personal income tax collected from direct, indirect, and induced employees would be approximately \$7.6 million.

#### **CHRISTIAN COUNTY INDUCED OUTPUT**

The graph below illustrates the output resulting from induced (consumer) spending in Christian County as the result of the 12 new/expanding businesses. A complete list of all impacted sectors can be found in the Appendices.





The **impact of capital investment** resulting from 12 announced projects is **more than \$574 million**, which includes an increase in **Christian County's GRP of almost \$258 million**. Labor income associated with this activity totals in excess of \$188 million.

The **2,000+ jobs created** in Christian County by the 12 identified projects have **total impact of \$1.6 billion**. The increase in **county GRP is nearly \$539 million**, with almost **\$288 million in labor income**. State and local tax impact is in excess of \$42 million.




#### **SUMMARY**

One project – Novelis – located in Todd County in 2022. The total impact of the Novelis capital investment and job creation is more than \$454 million in Todd County. The impact includes an increase in GRP of more than \$134 million and total labor income of nearly \$95 million in the county. ### Total Impact by Type








#### **State & Local Tax Detail**

Novelis made a total investment of more than \$400 million in Todd County. That investment resulted in a **total impact of nearly \$208 million**, with a **contribution to GRP of more than \$95 million**. Labor income associated with nearly 1,200 supported jobs during the construction phase is almost \$73 million.

Novelis created 140 jobs for its Todd County location. Those jobs resulted in a **total impact of \$246 million**, with **labor income reaching nearly \$22 million**. The county's **GRP also increased by nearly \$39 million**, with state and local taxes of more than \$4 million.

#### **NOTES**

Construction is a one-time event, and associated jobs are likely temporary or represent an existing employee working additional hours. For that reason, jobs are considered supported rather than created. It should be noted that incentives are not accounted for in this data. Incentives would only have an impact on the direct taxes paid by the benefiting company. Indirect and induced tax impacts, which are not affected by incentives, total more than \$10.1 million from capital investment and nearly \$17.7 million from employment.
